

TULLYMORE GOLF RESORT CANCELLATION POLICY

Package Reservations

All rooms and tee-times confirmed are ultimately the responsibility of the group leader/booking party, as are any final payment discrepancies and/or changes made within the cancellation periods to follow. It is solely the group leader/booking party's responsibility to ensure that the entire group is aware of Tullymore Golf Resort's policies and procedures.

- Full payment of golf package will be applied if cancellation occurs inside of thirty (30) days of arrival date for "Standard" accommodations, sixty (60) days for "Cottages/Residence Club", and ninety (90) days for the "Lodge".
- To avoid forfeiture of deposit amount, we require a notice of at least thirty (30) days prior to arrival date for "Standard" accommodations, ninety (90) days for "Cottages/Residence Club", and one hundred and eighty (180) days for the "Lodge".
- If you have any questions or need to make any changes, please contact your group leader/booking coordinator.

General Reservations

- Room ONLY cancellations (not associated with a golf package) must be made a minimum of 3-days prior to arrival date.
- Golf ONLY cancellations (not associated with a golf package) must be made a minimum of 72 hours to 2 weeks prior to date of play.
- Cancellations made after that time will result in full charge of ALL night's room charges for each room reserved and full charge of all green fees.

Golf Rain Check

- In the event of inclement weather, cancellation of golf rounds will be at the discretion of Tullymore Golf Resort, and a rain-check will be issued, valid for up to one year at the value of the cancelled golf round. No refund or rain-check will be issued for lodging or un-used portion of 'pre-purchased' Food and Beverage. In the event of an injury, rainchecks for golf ONLY may be considered if accompanied by a doctor's letter.

Golf Package Requirements:

- **Reservation Lead Time** - New guests/groups can only reserve space up to 11 months prior to arrival, as existing guest will have 30 days “First Right of Refusal” to decide if they wish to re-book their same space for the following year.
- **Golf Minimums** - A minimum of one (1) non-discounted round of golf per day (morning rates), per guest is required for each night’s accommodation, with at least two (2) non-discounted rounds for lodging on any weekend evening (Friday and/or Saturday night).
- **Stay Minimums** - A minimum of two (2) night’s accommodations are required on weekends (single night’s stays are allowed on weekdays only).
- **Occupancy Requirements** - Single occupancy of accommodations will only be allowed on weekday evenings (Sunday – Thursday), with double occupancy required on weekend nights. Weekend room minimums are as follows: “Standard Rooms” = 2 guests, “1-Bedroom Suites” = 3 guests, “Residence Club” = 8 guests, “Cottages” = 8 guests, “Lodge” = 20 guests.
- **Package Expiration** - Golf Package discounts will be provided up to 1 week prior to reservation date(s); after this time, ‘Public’ rates may apply.
- Additional requirements and restrictions may apply.
